Each record is defined as the PROGRAM-INPUT-RECORD-REDEF. For each "Pulled" file, the first record is a header record defined as PROGRAM-INPUT-RECORD. Each record type is 540 byte non-delimited text document. Imports easily into Excel type spreadsheet IF the record count is under 55,000 records.
